GENERAL TERMS

• The current tariff regulates the general terms and regulations under which STB "Emeritus Bank" PLC, Sofia (THE BANK) collects fees, commissions and expenses for its services.

• The tariff is subject to update by the Management board of THE BANK in case of change in the economic conditions.

• The tariff is applied to all customers of THE BANK.

• THE BANK executes only orders that in form and content meet the requirements of Decree № 3 of BNB and the internal regulations of THE BANK.

• THE BANK performs operations ordered by its clients on current, deposit and other accounts in local and foreign currency.


• THE BANK collects the fees and commissions specified in this tariff at the time of performing the respective service, but may also do so by subscription system on the basis of a separate written agreement.

• The Clients pay all fees and commissions charged in connection with their operations to foreign and local correspondents, as well as in all real postal, communication and other similar expenses of THE BANK, that occur in connection with their current and other operations.

• In cases where an operation consists of more than one of the listed services, fees and commissions are collected for each of these services separately.

• Fees and commissions are not collected for certificates and inquiries at the request of the BNB Court.

• No fees and commissions are collected for donation accounts and for special accounts to which provision of funds is remitted on provided cards or on commitments undertaken by THE BANK








• Current accounts and savings deposits are closed of their own motion, with uncollected service charges for a period of 6 months.



ADDITIONAL PROVISIONS

1. This Tariff shall apply only to natural and legal persons

2. Valuers:

2.1. On interest accounts in national currency – the date of posting.

2.2. On interest accounts in foreign currency – when debiting the account, the date of execution.

3. The fees and commissions in this tariff, which are taxed under the VAT Act, shall be value added tax included in their amount.

4. No fees or commissions shall be charged in the following cases:

4.1. Upon issuance of certificates at the request of the Court, the Prosecutor's Office and the investigative bodies;

4.2. For all operations in BGN related to the disposition of donation accounts and to the raising and spending of funds for treatment, after submission of the relevant documents;


5. In the absence of an assets in a client's account for payment of the fees and commissions due under this tariff, UBB "Emeritus Bank" AD has the right to collect the same from other accounts opened by it in BGN (without accounts reporting deposits with a specified


time limit).

6. UBB "Emeritus Bank" AD reserves the right to collect the fees and commissions from the originator in cases where his orders indicate that they are on behalf of the beneficiary and UBB "Emeritus Bank" AD manages to collect them from the latter.

7. For all services not specified in this tariff, UBB "Emeritus Bank" AD collects fees and commissions under an arrangement.


8. For the provision of complex services, specific operations and other additional services, operations and activities, UBB "Emeritus Bank" AD reserves the right to collect additional fees and commissions.
